GALEN GRABER MADE A MOTION TO ACCEPT THE CONTRACT AS STATED. RONALD BOYD SECONDED THE MOTION. GALEN GRABER AND LANA HELMS ACCEPTED THE MOTIONS AND RONALD BOYD VOTED NO.

UPON A RECOMMENDATION FROM SUPERINTENDENT TRAVIS MADISON AND HEAD CUSTODIAN MARK YODER, THE BOARD APPROVED TIARA KENNEY, JENNA KNEPP, BALEIGH LENGACHER, DAMON PRUETT, ADAM GRABER & TREVOR YODER AS SUMMER HELPERS AT \$8.00/HOUR. RONALD BOYD MADE A MOTION TO ACCEPT THESE POSITIONS AS STATED. LANA HELMS SECONDED THE MOTION AND MOTION CARRIED.

NO FINANCIAL REPORT WAS PRESENTED.

IN REPORTS, MR MADISON PRESENTED THE CRIMINAL GANG POLICY AND INTERNAL CONTROLS POLICY FOR A FIRST READ TO BE APPROVED AT A FUTURE MEETING. TERI HOLT ASKED A QUESTION ON THE INTERNAL CONTROLS POLICY.

MR MADISON GAVE PRESENTATION OF A POSSIBLE RENOVATION ON THE ELEMENTARY ENTRANCE FOR OFFICE SECURITY. HE STATED THAT THERE WOULD BE BIDS TAKEN UNTIL 1PM ON APRIL28, 2016. THERE WERE QUESTIONS OR COMMENTS FROM ANNETTA GRABER, KORY BOYD, CAROL BOYD AND JOAN

SCHUTZ. MR MADISON ASLO STATED THAT AT THE NEXT BOARD MEETING THE ARCHITECT WOULD BE THERE TO GIVE A PRESENTATION.

PRIOR TO ADJOURNMENT, LANA HELMS WANTED TO RECOGNIZE HER FELLOW BOARD MEMBERS AND THANKED THEM FOR THE TIME THEY TAKE TO MAKE THE BEST DECISIONS FOR THE SCHOOL.
