ON THE CALL OF THE ROLL, BOARD MEMBERS LANA HELMS, GALEN GRABER AND RONALD BOYD WERE PRESENT. ALSO PRESENT WERE THE SUPERINTENDENT TRAVIS MADISON AND THOSE LISTED ON THE ATTACHED SIGN-IN SHEET.

PRESIDENT RONALD BOYD CALLED THE MEETING TO ORDER.

THE BOARD APPROVED AUTHORIZATION FOR THE SUPERINTENDENT TRAVIS MADISON, ELEMENTARY & HIGH SCHOOL PRINCIPALS TO APPLY FOR STATE AND FEDERAL GRANT PROGRAMS INCLUDING HIGH ABILITY LEARNERS, TITLE I, II, IV, V, VI AND SCHOOL LUNCH PROGRAM. RONALD BOYD MADE A MOTION AND LANA HELMS SECONDED. MOTION CARRIED 3-0.

RONALD BOYD MADE A MOTION TO APPROVE CORPORATION TREASURER TO PAY ANY BILLS THAT NEEDED TO BE PAID BY JUNE 30, 2016. GALEN GRABER SECONDED THE MOTION AND MOTION CARRIED 3-0.

IN FINANCIAL REPORTS, MR MADISON GAVE A BRIEF FINANCIAL REPORT OF CURRENT CASH BALANCES AS COMPARED TO LAST YEAR AT THIS TIME.

PRIOR TO ADJOURNMENT, GALEN GRABER CONGRATULATED JOSH SWARTZENTRUBER ON PASSING HIS TEACHING LICENSE TEST. HE ALSO CONGRATULATED JOE RADEMACHER AND THE BASEBALL TEAM ON THEIR

SECTIONAL CHAMPIONSHIP. MR GRABER ALSO WANTED TO CONGRATULATE THE ADMINISTRATORS, TEACHERS, PARENTS AND STUDENTS ON THE 4-STAR SCHOOL AWARD THAT WE RECEIVED.

LANA HELMS WANTED TO THANK THE PEOPLE SHE TALKED TO ABOUT BEING ON THE COMMITTEE. SHE ALSO WANTED TO THANK THE CUSTODIAL STAFF FOR THE EXTRA WORK THAT THEY HAVE WITH THE CONSTRUCTION PROJECT.

RONALD BOYD ADDED THAT BARR-REEVE TOP TO BOTTOM IS A VERY GOOD SCHOOL CORPORATION AND WE HAVE A GREAT SUPPORT SYSTEM.
